Air duct connector consisting of an all-aluminum exposed surface laminate encapsulating a galvanized wire helix.

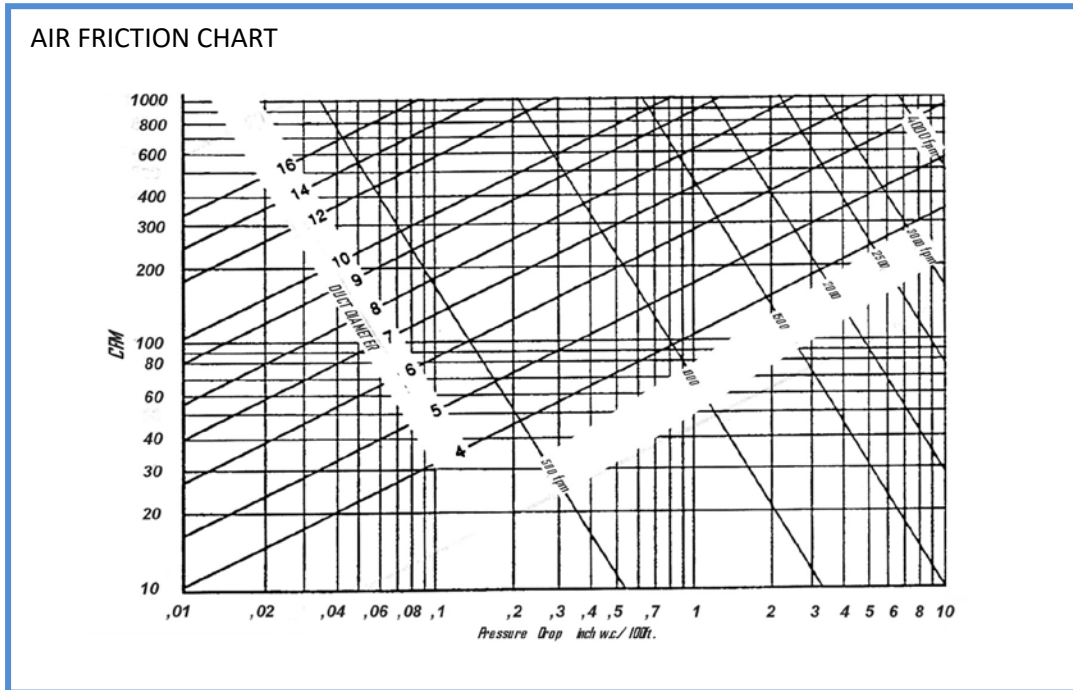
